Legal ground: Article 70 point 3 of the Act on Public Offering – General Meeting of Shareholders; list of shareholders above 5%

Report content:

Acting pursuant to § 6 section 2 of Regulation of the Minister of Finance on current and periodic information submitted by issuers of securities, the Board of RADPOL SA based in Człuchów ("Company") provides a correction to current report no 10/2010 of 23 February 2010 concerning the list of shareholders possessing at least 5% of number of votes at the Extraordinary General Meeting of Shareholders of RADPOL SA, as at 19.02.2010

In the current report no 10/2010, the Company has erroneously indicated the number of shares that are managed by BZ WBK AIB Asset Management SA. The Company did not include that the BZ WBK AIB Asset Management SA manages shares belonging to the following funds: LUKAS FUNDUSZ INWESTYCYJNY OTWARTY SUBFUNDUSZ STABILNEGO WZROSTU, LUKAS FUNDUSZ INWESTYCYJNY OTWARTY SUBFUNDUSZ DYNAMICZNY POLSKI and LUKAS FUNDUSZ INWESTYCYJNY OTWARTY SUBFUNDUSZ AKCYJNY.

As a result, BZ WBK AIB Asset Management SA at the Extraordinary General Meeting of Shareholders of RADPOL SA on 19 February 2010 registered 2,230,000 shares of the Company and thus had 2,230,000 votes, representing 9.31% of the total number of votes in the Company and 12.29% of the number of votes at the general meeting. Previously issued information stating that BZ WBK AIB Asset Management SA registered 1,750,000 shares of the Company was incorrect and is therefore subject to correction.

Other information included in the current report no 10/2010 are correct and shall not be altered.
